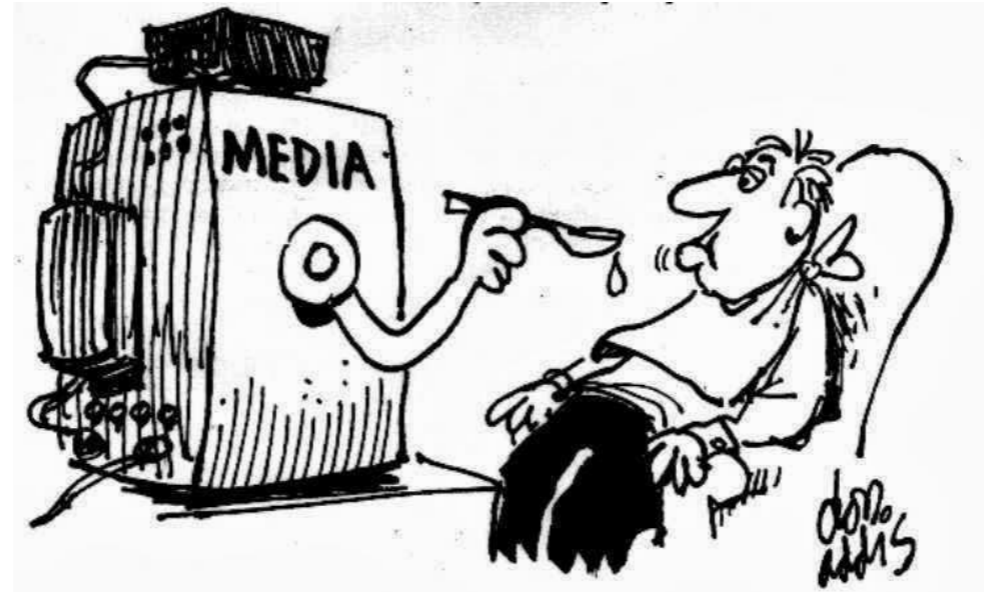

The Indian government is to ban the use of Bitcoin and other cryptocurrencies for payments, finance minister Arun Jaitley has announced, kicking Bitcoin's already-sliding value further down the slope.

NEW DELHI (Reuters) - India will move to stamp out use of cryptocurrencies, which it considers illegal, Finance Minister Arun Jaitley said on Thursday, launching a no-holds-barred attack on virtual currencies such as Bitcoin.

But in reality, Hon.
Finance Minister of India
had said

“India doesn’t consider cryptocurrencies legal tender and will take all measures to eliminate use of these crypto-assets in **financing illegitimate activities** or as part of the payment system, while **exploring the use of blockchain technology**.”

- India’s FM Arun Jaitley during his 2008 Budget Speech

Doordarshan Host: We've seen a lot of excitement over bitcoins. Why aren't you banning it instead of stating it isn't legal tender?

Jaitley: We are discouraging people from using it now. There is a government committee that's looking into it right now and they will announce their decisions and next steps after they are done.

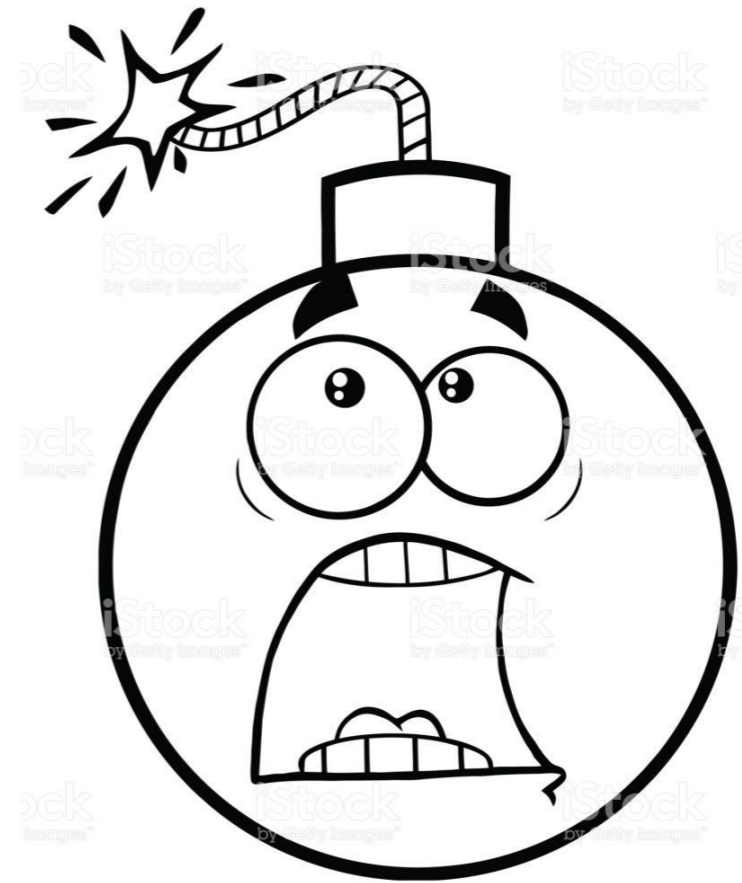

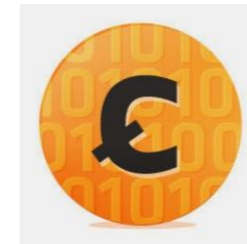
